**Official Sweepstakes Rules**

THERE IS NO PURCHASE NECESSARY TO ENTER OR TO WIN A PRIZE;

TO QUALIFY AS AN ELIGIBLE ENTRANT.

**1) Description of Sweepstakes/How to Enter: No Purchase Necessary.** Retail Promotions, LLC (the "**Sponsor**") is offering the "Michael Payne \$5,000 Exciting Windows! Makeover Sweepstakes" (the "**Sweepstakes**") and will award one (1) Grand Prize via a random selection of eligible entrants. The Sweepstakes begins January 1, 2011 at 12:01:01 AM US Eastern Time (ET) and ends May 31, 2012 at 11:59:59 PM, US ET, ("**Sweepstakes Period**").

There are two ways to enter. On-line: Visit **Error! Hyperlink reference not valid.** and complete the registration form by providing your first name, last name, street address, city, state/province, zip/postal code, home phone number including area code, and your email address. You will be asked to respond to five (5) market survey questions as a condition of valid entry. You will have the opportunity to "opt in" to receive further communication from Exciting Windows! Opting to receive further communication from Exciting Windows! is NOT a condition for valid entry in the Sweepstakes nor does it increase your chances of winning. By hand-printed Official Entry Form: Complete an Official Michael Payne \$5,000 Exciting Windows Makeover Sweepstakes entry form ("Official Entry Form") as found in special Sweepstakes materials distributed by representatives of Exciting Windows! Hand print your first name, last name, street address, city, state/province, zip/postal code, home phone number including area code, and your email address to complete the Official Entry Form. You can deposit the Official Entry Form at the Sweepstakes display in an Exciting Windows! Showroom in your area, or mail the entry form to: Exciting Windows! \$5,000 Makeover Sweepstakes, 7758 Wisconsin Ave. Suite 304, Bethesda, MD 20814. Official Entry Forms must be deposited at Exciting Windows! Showrooms no later than end of business on June 1, 2012. If you mail your Official Entry Form it must be postmarked no later than June 1, 2012 and received no later than June 8, 2012. Limit, one entry per person and per household regardless of entry method.

**2) Eligibility:** Sweepstakes open ONLY to individuals 18 years of age or older, who are homeowners as of January 1, 2012 and legal residents of the United States, the District of Columbia and Canada, excluding residents of HI and Quebec. Sweepstakes is void in HI, Quebec and where prohibited or restricted by law. Employees, officers and representatives

(and members of their immediate families and those living in the same household of each) of Retail Promotions, LLC and Exciting Window! Network, LLC, its parent, subsidiaries, affiliated companies, agents, representatives, advertising and promotion agencies and any company involved in the design, execution or production of the Sweepstakes are not eligible.

**3) Prizes: One (1) Grand Prize** – A \$5,000 Exciting Windows! Makeover, (“**Grand Prize Window Makeover**”) Approximate Retail Value (ARV) – \$5,000 USD. The Grand Prize Window Makeover consists of an in-home consultation by an Exciting Windows! professional for the interior windowed area of the home specified by the verified winner, a written design recommendation from HGTV’s Michael Payne, based on the photographs from the in-home consultation and up to \$5,000 of Exciting Windows! products and services. The verified winner however, has no obligation to use the design recommendations as submitted by the Exciting Windows! professional and/or those of Michael Payne and may collaborate with the Exciting Windows! consultant to determine his/her own specifications for the use of the \$5,000 in Exciting Windows! products and services. Grand Prize winner must ensure the installation of the \$5,000 in Exciting Windows! products and services is completed in his/her home within six (6) months of being named a verified winner. If the installation cannot be completed in this period of time, Sponsor has the option to disqualify the winner and award the prize to an alternate.

The value of the components in the Grand Prize Makeover will be based on the Exciting Windows! price list, published as of February 1, 2012, including any applicable sales tax. If the final selections identified for the Grand Prize Window Makeover by the verified winner is less than \$5,000 in Exciting Windows! products and services, there is no cash option or refund for the difference. Grand Prize Window Makeover will only be installed in the home documented as belonging to the verified winner. There is one (1) prize with an overall value of up to \$5,000 USD. **4) General:** The Grand Prize winner will be selected in a random drawing from all valid entries on or about June 22, 2012. Grand Prize winner will be notified via phone and/or mail within five (5) business days of the drawing and will be required to complete an Affidavit of Eligibility and a Liability/Publicity Release (unless prohibited by law), (“**Prize Affidavit**”). The Prize Affidavit must be returned within ten (10) days Sponsor’s provision of these documents. Potential winners will also be required to send a copy of his/her passport, driver’s license, birth certificate or other appropriate documentation (acceptable to Sponsors) as proof of age and residency. Additionally the potential winner will be required to provide a photocopy of home loan or deed, (or other document deemed acceptable by the Sponsor) which documents home ownership as of January 1, 2012. Non-compliance with any of these requirements will result in disqualification, in which case an alternate winner will be chosen. Return of prize notification and/or the Affidavit/Release as undeliverable will result in disqualification and an alternate winner will be selected. In compliance with Canadian law, if a Canadian resident is the potential Grand Prize winner, he/she will be required to correctly answer a multiple part mathematical skill question as a condition of being named a verified winner.
